- 2) Mail both forms in the same envelope with the supporting documentation listed below within 60 days of your purchase.
 - a. Original eye exam receipt with date circled.
 - b. Original sales receipt showing proof of payment for your eligible contact lens purchase(s). Purchase must be made within 60 days of eye exam. Circle contact lens purchase and date on receipt.
 - c. Original UPC symbols from EACH qualifying box. **Copies of UPC symbols do not qualify.**
 Example: Purchase 2 boxes, submit 2 UPCs. | Purchase 4 boxes, submit 4 UPCs.

Submission must be postmarked within 60 days of your contact lens purchase. All receipts must be from the same eye care practitioner who prescribed your contacts, or from a location affiliated with that practitioner.
